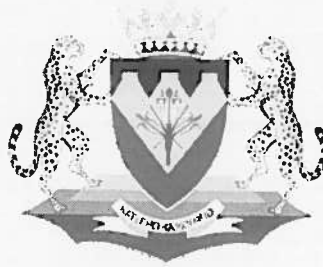

PROCLAMATION

[No. 7 of 2014]

By virtue of the powers vested in me by section 4 of the Nature Conservation Ordinance, 1969 (Ordinance No. 8 of 1969), I, Mosebenzi Joseph Zwane, Member of the Executive Council responsible for Economic Development, Tourism and Environmental Affairs in the Province, hereby declare that any authorised person may hunt/capture ordinary game as follows:

Free State Province Hunting Season	
Species of "ordinary game" in accordance with Schedule 2.	Period during which hunting or capturing of "ordinary game" may take place.
<p>Helmeted Guineafowl (<i>Numida meleagris</i>), Swainson's Spurfowl (<i>Pternistes swainsonii</i>) Grey-winged Francolin (<i>Scleroptila africanus</i>), Orange River Francolin (<i>Scleroptila levaillantoides</i>), Common Quail (<i>Coturnix coturnix</i>).</p> <p>Egyptian Goose (<i>Alopochen aegyptiacus</i>), Spur-winged Goose (<i>Plectropterus gambensis</i>), Yellow-billed Duck (<i>Anas undulata</i>), Red-billed Teal (<i>Anas erythrorhyncha</i>).</p> <p>Red knobbed Coot (<i>Fulica cristata</i>).</p> <p>Springbok (<i>Antidorcas marsupialis</i>) Blesbok (<i>Damaliscus pygargus phillipsi</i>), Blue Wildebeest (<i>Connochaetes taurinus</i>), Bushbuck (<i>Tragelaphus scriptus</i>), Gemsbuck (<i>Oryx gazella</i>), Giraffe (<i>Giraffa camelopardalis</i>), Red Hartebeest (<i>Alcelaphus buselaphus</i>), Impala (<i>Aepyceros melampus melampus</i>), Burchell's Zebra (<i>Equus burchellii</i>), Waterbuck (<i>Kobus ellipsyprimus ellipsyprimus</i>),</p>	<p>1st May up to and including 31st August.</p> <p>A maximum of ten (10) terrestrial gamebirds, and ten (10) waterfowl per hunter per day (including wounded birds and those not retrieved).</p> <p>Hunters must be aware that, depending on conditions, some of these game birds and waterfowl breed in the Open season and, apart from Common Quail <i>Coturnix coturnix</i>, may be hunted only if in flocks of three or more.</p> <p>1st January to 31st December if farm has been issued with an adequate fencing certificate in terms of section 2(2)(a) of the Game Theft Act, 1991 (Act No. 105 of 1991) and that the species to be hunted is specified on the certificate.</p> <p>1st April to 30th September. Animals may be hunted on farms that have not been issued with an adequate fencing certificate in terms of section 2(2)(a) of the Game Theft Act, 1991 (Act No. 105 of 1991).</p>

<p>This hunting proclamation comes into effect on the 1st day of January 2014 and remains valid until such time that it is re-evaluated and amended by proclamation in the <i>Provincial Gazette</i></p>
